# **HBI-PACT Program Partnership Grant Application**



The Texas Builders Foundation is offering grants to enable eligible organizations to purchase the Home Builders Institute (HBI) curriculum for construction trades training. High schools, community colleges, vocational and technical schools, non-profit organizations (such as Habitat for Humanity chapters) – to name a few – that partner with a Texas home builders association are eligible to apply for a PACT curriculum license through this grant program.

Grants will be awarded in the amount of (or up to, based on need) \$8,800 per organization: \$6,000 for first year HBI Licensing Fee; \$1,800 In-Person Instructor Training (2 instructors); \$1,000 for student assessments (up to 20 students @ \$50 per assessment/certificate).

#### **Grant Process**

- 1. Grant applications will be reviewed and considered as received.
- 2. Allow up to 30 days for the review period.
- 3. If accepted, allow up to 30 days for the Licensing Agreement to be drafted and finalized.
- 4. Instructor training will begin upon signing of the Agreement.
